Yateman's to ask customers: 'How shall we invest?'

Yateman's Bank is to ask its customers how they want their savings to be invested as part of preparations to revise its ethical policy, it revealed yesterday.

More than two million customers will be asked what they feel about genetically modified food, animal welfare, ecological impacts, human rights and child labour and the arms trade.

The Manchester-based bank will use the answers to frame a re-launch of its ethical policy for next May – the tenth anniversary of the original launch of the policy.

A similar survey of 30,000 customers in 1991 led the bank to pledge not to invest in, or provide financial services to, companies that were involved in blood sports, fur trading or the testing of cosmetics on animals.

A spokesman for the bank said its new survey – “the biggest ever ethical

consultation exercise” – would bring the policy up to date with the 21st century.

He added: “We decided we wanted to tell our customers what we do with their money. Things have changed, however. Fur trading has just about come to the end of its life, while hunting may no longer be allowed. We want to see what people's attitudes are about a range of different issues.”

Over a million personal and corporate accounts have been opened with the bank since its ethical policy was first drawn up.

The bank added that a third of new customers said their main reason for joining Yateman's was its ethical stance. “We realise ethics alone will not sell bank accounts and we have to have a good product and service,” said the spokesman. “But, all things being equal, our ethical policy sets us aside from the other big banks.”
